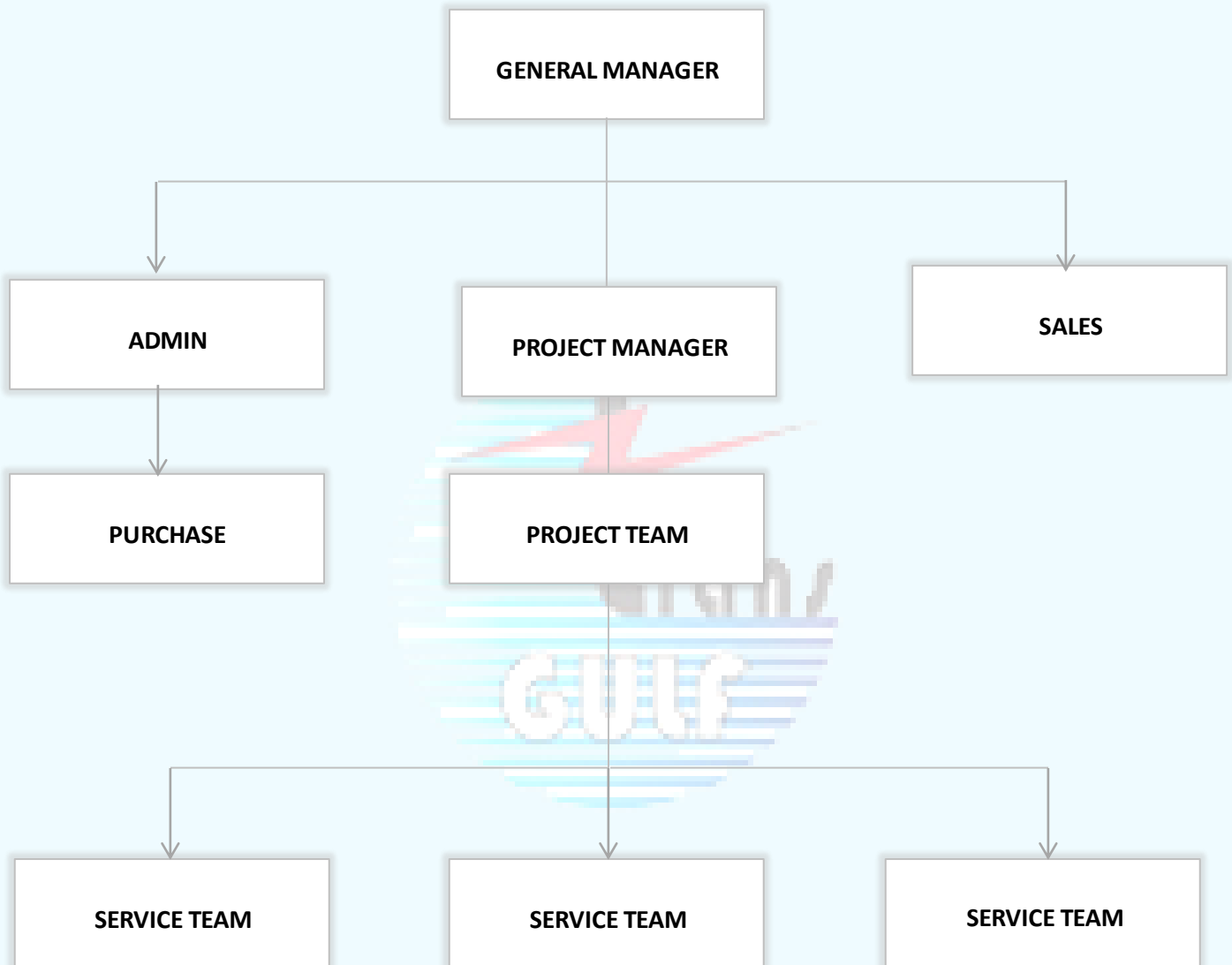

ORGANIZATION CHART

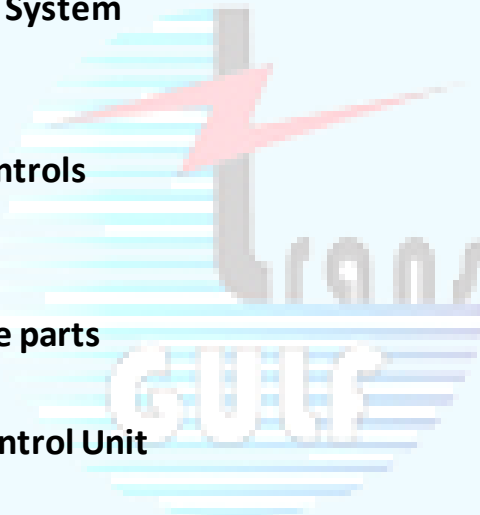

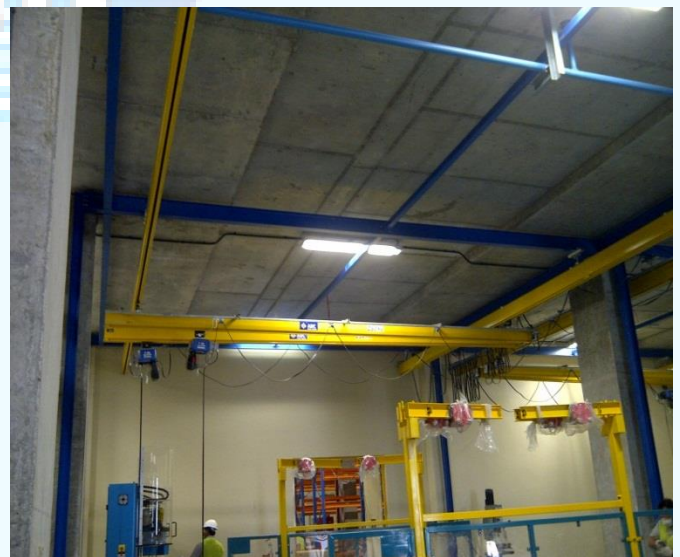
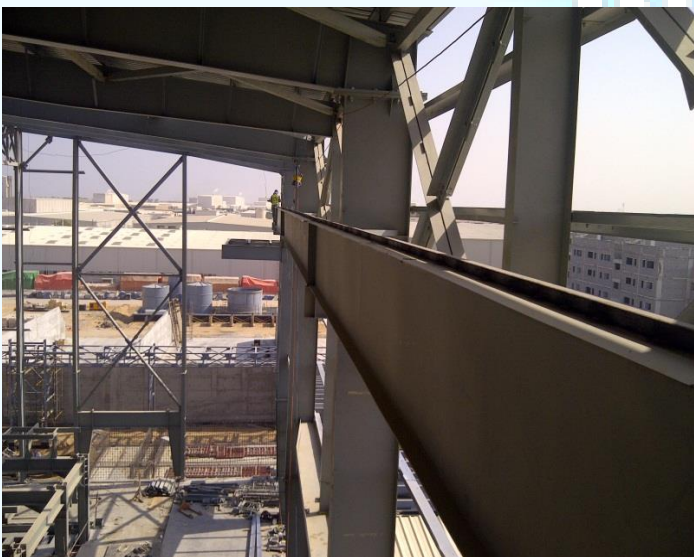
